



Letter from the Chief

I am pleased to present the New Jersey State Park Police 2022 Annual Report to Commissioner LaTourette, employees of the Department of Environmental Protection, and the many visitors of our State Parks, Forests, & Historic Sites.

The 2022 Annual Report includes information about how we are continuing our mission to protect the Natural Resources & Historic Treasures of our State's Parks, Forests, & Historic Sites and the safety, security, and well-being of all who visit them. This report highlights the efforts by the State Park Police to improve public safety and engagement of our visitors through community policing initiatives and educational campaigns.

Moving through 2022, we finally began to feel the grasp of COVID loosen. While the State Park Police worked diligently through the pandemic, the world moved from a nearly all virtual environment to becoming more comfortable with once again seeing each other in person. One positive outcome of the virtual environment was discovering the ability to communicate over long distances, which in some ways, made our work productivity more efficient. The COVID restrictions provided the opportunity for many families to become closer and spend valuable time together that many of us took for granted pre-pandemic. With the increased family time, came increased visitation to our State Parks, Forests, & Historic Sites. Through all of this, the State Park Police responded to over 15,000 calls for service as visitation peaked at just over 16.7 million visitors.

As the State Park Police embark into 2023 under my leadership, the organization will undergo a transformation to better align our priorities with the State Park Service. The first step in this process is realigning the State Park Police command structure to mirror that of the Park Service and allow for more effective and efficient communication between our two agencies. Diversifying our recruiting and retention initiatives will be prioritized to fill voids within our ranks. We will develop our staff to continue and grow our longstanding tradition of serving as ambassadors of our natural resources & historic treasures.

It is my pleasure to work alongside the dedicated staff of the State Park Police. On behalf of our officers and civilian staff, we look forward to improving and building relationships in and around our park communities and to provide the best possible experience to those who visit our State Parks, Forests. & Historic Sites.

The New Jersey State Park Police patrol and protect the State's Parks, Forests, Recreation Areas, Historic Sites and Natural Land Trust Preserves.

We are a diverse group of men and women dedicated to safeguarding New Jersey's resources 24 hours a day, 7 days a week.

The New Jersey State Park Police are empowered with the same law enforcement authority as all New Jersey municipal, county and state police officers.

We respond to public safety emergencies as well as environmental emergencies. Through various methods of patrol, including but not limited to foot, bike, boat and motor, we provide courteous, professional, knowledgeable assistance and services to the public at all times. The State Park Police also provide mutual aid assistance to municipal, county, state and federal law enforcement agencies.








Citations Arrests and Reports

The New Jersey State Park Police patrol with statewide law enforcement authority enforcing criminal, motor vehicle, state park, environmental, conservation, animal cruelty and many other laws in NJ.



Officers perform public assistance and resource protection as a sworn law enforcement officer at state parks, forests, recreation areas, historic sites, marinas, and botanical gardens, and other State Park Service lands and facilities. Officers act as liaisons with the public enforcing laws and regulations for the protection and management of the health and safety of people and natural and historical resources. They educate and inform the public, through a working knowledge of State forestry, wildlife, habitat and watershed management practices, regarding the rules, regulations, laws and management practices of State Park Service and to enhance environmental awareness and Stewardship. As well as providing security services for people, water, land, and structures under the guidelines of Homeland Security.


Vehicle Break-Ins









New Jersey State Park Police 2022 Statistics ATV Complaints





Areas of State Parks have features that the general public can not gauge the hazards, depths, currents or dangers of properly, creating dangerous conditions and situations when improperly accessed.















New Jersey State Park Police 2022 Internal Affairs



The New Jersey State Park Police are committed to fostering strong Police-community relationships and public trust. State Park Police Personnel are held to the highest standard of professional conduct because of the power inherent in the exercise of law enforcement authority, including the power to detain, arrest and the power to use deadly force.

The Internal Affairs Bureau (IAB), under the supervision of a Professional Standards Lieutenant, is responsible for receiving, processing and assigning the investigation of any alleged misconduct or criminal conduct by any member of the Department. The IAB ensures all allegations are investigated thoroughly and objectively.

All members of the Department are directed to accept all complaints of officer misconduct from all persons, regardless of time of day or day of week and whether received in person, via telephone or in writing.

Complaint determinations:

- <u>Exonerated</u>: the alleged incident did occur, but the actions of the officer were justified, legal and proper.
- <u>Sustained</u>: the investigation disclosed sufficient evidence to prove the allegation, and the actions of the officer violated provisions of rule and regulation or department written directives.
- <u>Not Sustained</u>: the investigation failed to disclose sufficient evidence to clearly prove or disprove the allegation.
- Unfounded: the alleged incident did not occur.

New Jersey State Park Police Detective Bureau



For the majority of 2022 the NJSPP Detective Bureau operated with two new Detectives and one Detective Sergeant. Another, much needed Detective was added before the start of 2023.

During 2022 the NJSPP Detective Bureau (DB) handled and/or processed approximately 118 cases statewide. Of those cases 75 were closed. The Detective Bureau currently has 43 open cases.

The NJSPP DB is on call 24/7.

They support the NJ State Park Police with tasks and operations like disseminating Intelligence, Safety Bulletins, responding to HOT calls where extra manpower is needed, assisting with identification procedures, plain clothes details for large scale special events, assisting patrol with criminal complaints, conducting background investigations, plainclothes and proactive patrols, and numerous other responsibilities.

NJSPP Detective Bureau Establishes a TIP LINE

In December 2022, the NJSPP Detective Bureau setup the first NJSPP Tip Line in English and Spanish. The Tip Line is to assist with Important cases where many tips would come into the park. This assists our DEP Dispatchers slow down some of their call volume.

March 2022

Burglary/Criminal Mischief Suspect Identified and Arrested through DNA

In March 2021 an unknown suspect broke into D&R Canal State Park's Carnegie House and stole \$1,600 in property and caused \$2,000 in damages, but left a cup on scene. DNA was recovered from the lip of the cup and in March 2022 the DNA results came back. A suspect was identified, interviewed, confessed, and was charged with the Burglary and Criminal Mischief.







NJSPP DB Investigates Sexual Assaults in D&R Canal State Park

NJSPP Detectives maintained surveillance cameras, handed out flyers, spoke with the Public and Park Staff regarding several Sexual Assaults that occurred in and around D&R Canal State Park over the past two years.

NJSPP DB participated in Task Force meetings regarding these cases and assisted with plain clothes details in and around D&R Canal State Park. Detectives maintained communication with the lead investigating Prosecutor's Offices (Middlesex and Somerset Prosecutor's Offices) and provided updates on leads.

A suspect was identified, arrested, and charged by the Middlesex and Somerset Prosecutor's Offices in August 2022.



New Jersey State Park Police 2022 Noteworthy Cases



April 2022

Brendan T. Byrne Spring Lake Fire Suspect: Charged

Detectives worked with NJ Forest Fire Investigators and followed up leads to the Spring Lake Fire. The Detective Bureau was able to identify, locate and interview possible suspects, all of which were homeless grifters.

Ultimately there was not enough evidence to charge suspects with setting the fire, but suspects were charged with other criminal and park related charges in lieu of Arson charges.



May 2022

Armed Robbery at Liberty State Park

Detectives responded to Liberty State Park for an armed robbery with a handgun where thousands of dollars in jewelry was robbed from the victim.

The robbery occurred on a walking path near the Nature Interpretative Center and video surveillance footage was recovered.

Detectives are working with the Jersey City PD and Hudson County Prosecutor's Office in the ongoing investigation.



New Jersey State Park Police 2022 Noteworthy Cases



Sexual Assault Parolee Search Along the Batona Trail

Detectives teamed with the US Marshalls and NJ Parole to conduct extensive searches of the Batona Trail. An isolated campsite was located where belongings were collected forcing the suspect into the open, resulting in his capture.

June 2022

Missing Person Located in Wharton State Forest: Deceased

Detectives teamed with NJSP Missing Persons Unit, Camden County Search and Rescue, Waterford, and Cherry Hill PD to locate a missing person last seen in Wharton State Forest.

Detectives utilized ATV's and off-road equipment, conducted grid searches, foot searches, and bike searches resulting in the missing person's remains being recovered.

DB Responds to Brendan T. Byrne for Male Threatening to Harm NJSP and NJSPP Officers: Ends Peacefully

Our Detective Sergeant responded to Brendan Byrne for a male with a warrant, threatening to harm NJSPP Officers and NJSP Troopers.

The Sergeant was able to speak with the subject, deescalate the situation and safely place the suspect in custody and transport him to jail.

The suspect was later charged with Animal Cruelty along with other charges.

July 2022

NJSPP Detective Bureau Assisted with Targeted Patrol of D&R Canal-Frenchtown-Commended by Mayor and Hunterdon County Prosecutor

NJSPP Detectives assisted NJSPP Patrol with targeted patrol of Frenchtown area of D&R Canal State Park due to threats of violence and disorder.

The Detective Bureau and NJSPP patrol were commended by the Hunterdon County Prosecutor and the Mayor of Frenchtown for their efforts.



August 2022

Overdosed Suicidal Subject located along Mullica River Road in Wharton State Forest: Saved

NJSPP Patrol units along with our Detective Sergeant and Operations Lieutenant were able to locate a missing, suicidal, and endangered female who overdosed on CDS.

With quick coordination they were able to safely evacuate her from the woods and transport her to the hospital, which subsequently saved her life.

September 2022

Liberty Science Center Bomb Threat Suspect Identified by NJSPP DB

The Detective Bureau, working with the ATF and US Attorney's Office was able to identify the individual making threats against the Liberty Science Center through computer information linked to the threats.

An NJSPP Detective interviewed the suspect and charges are pending.

October 2022

NJSPP Detective Locates Deceased Individual on NJ Fish and Wildlife Property

While enroute to training an NJSPP Detective stopped to assist, what he thought was a disabled vehicle. He discovered the male driver deceased. The detective assisted with securing the scene and turning the scene over to NJSP and NJ F&W.

Suspect Destroys Liberty State Park Bathroom, Identified by DB

An NJSPP Detective investigated a male suspect who damaged a Liberty State Park bathroom and water fountain. The detective, utilizing video footage, was able to positively identify the suspect. The suspect was interviewed and charges are pending.

Male Suicide Victim Found Semi-Unconscious at Stephens State Park

NJSPP Patrol responded to Stephens State Park for a male having an unknown medical emergency. NJSPP Detectives responded to the scene and determined the victim utilized a nail gun in order to attempt suicide. The victim passed away a few days later.

After an extensive investigation spanning Northern NJ it was determined the victim committed suicide. The nail gun was tested for ballistics by NJSPP Detectives and this case has been ruled a suicide by the Medical Examiners office with the extensive help of the NJSPP Detective Bureau.

Recent and On-going cases are currently under investigation.

Liberty State Park was used as the kickoff staging site for part of the tour this year. 2022 marked the 20th anniversary of the first post-9/11 Unity Tour ride.










